A player's age and grade will be the guidelines for a player's eligibility. Birth Certificates or acceptable forms of proof of age as outlined below are required for all players, at all times. If a player is participating using the grade exception, they will also be required to have a current report card or school I.D. on site at all games. The player must appear on the roster. Any ineligible player MAY cause the team to be disqualified or put in as last seed. Each case will be looked at by the the tournament directors to determine if the player is ineligible. Failure to produce proof of age documentation upon request of the tournament directors will result in the player being declared ineligible for participation. Final determination of eligibility is at the discretion of the tournament directors. Acceptable forms of proof of age/grade are:A certified copy of a U.S. birth certificate; Certified documentation of naturalization; Military Certificate of birth or passport; Current school issued report card; Official school ID with grade.
